

# Loaner Device Agreement

## Purpose

Lingraphica's Loaner Device program is designed to provide in-depth exposure to Lingraphica speech-generating devices for purposes such as client screening, introductory demonstration to clients and their family members, professional development, staff training, and therapeutic use.

All device borrower obligations are free of charge. SLPs may have the opportunity to earn ASHA-accredited CEUs by participating in certain activities. ## Obligations of Lingraphica

- Provide a standard warranty with the loaner device.
- Cover all shipping and other costs related to the loaner device.
- Provide training on the use of the device.
- Assist in the management of Protected Health Information (PHI) on the device.

## Obligations of the Device Borrower

- Secure and properly care for the device.
- Engage with Lingraphica regularly in order to stay up-to-date on new device features.
- Alert Lingraphica if a device has a technical issue or a charging cord is lost so that the device can be maintained at no cost to the SLP or facility.
- Collaborate with Lingraphica for regular device maintenance.
- Alert Lingraphica of any contact information changes or if possession of the device changes.
- Request a device from Lingraphica for client to use during device trial period; borrowed device referenced in this agreement is not intended for trial use.
- Assume responsibility for all content added and any changes made to the device; follow instructions to reset device and remove PHI or added content, or contact Product Support for assistance.

## Additional Terms

- The parties agree & acknowledge that the loaner device and related training have no independent value to the facility and is not being provided as an incentive or reward for determining that a client will benefit from a Lingraphica SGD.
- This Agreement does not obligate anyone to recommend or prescribe Lingraphica SGDs or other products.

# Lingraphica Loaner Device Agreement

- Lingraphica Loaner Devices may not be “unlocked” to allow the addition of external apps or programs.
- The Borrower is not liable for loss/damage/theft of the device.
- The Borrower can enter and exit Lingraphica’s loaner program at will simply by returning or requesting a loaner device.
- The Borrower agrees to return the loaner device at Lingraphica’s expense when no longer using the device or is no longer able to collaborate for regular maintenance.
